READY TO USE

DIRECTIONS FOR USE

1. Remove all loose soiling from the area to be cleaned. Spray generously about 12 inches from the stained area.
2. **DO NOT SCRUB OR BLOT THE TREATED STAIN.** Just Spray and Walk Away.
3. Allow area to dry, **PROXI** will gradually break down and remove the stain and remain active up to 3 days. Retreatment maybe necessary in cases of severe staining.
4. On deep pile carpets, work **PROXI** into the pile lightly with a clean rag or light brush. Do not scrub or blot.

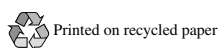
